Members of the Senate Redistricting Subcommittee:

I would like to provide the following feedback regarding the Senate Judiciary Staff Senate Plan for Redistricting that was released on June 2, 2011.

I strongly disagree with the proposed changes to transition the Greenbriar precinct from State Senate District 8 to District 7. I believe that moving the Greenbriar precinct from Senate District 8 to District 7 would sever its ties to the principal community of common interest to which Greenbriar belongs.

I have been a part of the Greenbriar precinct since becoming a resident of Mauldin in 1996. Residents in the Greenbriar precinct are generally associated with the area known as the Golden Strip which encompasses the Mauldin and Simpsonville communities. Members of the Greenbriar precinct primarily shop, share faith congregations, and participate in sports and recreation programs in the Mauldin and Simpsonville areas.

The overwhelming majority of the Mauldin and Simpsonville areas remain part of Senate District 8. I believe that moving the Greenbriar precinct out of District 8 would negatively impact the Greenbriar community of common interest and therefore respectfully ask that the Greenbriar precinct be retained in State Senate District 8.


To the Senate Judiciary Sub-Committee,

For the past decade Colleton County has been represented by six member Legislative Delegation, which has given us strong representation in Columbia. We have had several issues requiring the attention of the General Assembly, and the members of our Delegation have worked together to address these issues. These issues have ranged from economic development to constituent service needs. One example is the Victory House Nursing Home outside Walterboro. The facilities construction was funded by the efforts of our Legislation Delegation. Without these efforts to secure funding for its construction it would not have become a reality. Also, this facility employs several hundred people from our area. Highway 17A, which runs through Colleton County is now being four-laned.
