## **PRESS RELEASE REDISTRICTING PLAN SUBMITTED**

(Columbia) – The Congressional redistricting plan approved by the South Carolina House of Representatives and the South Carolina Senate at the end of the 2011 legislative session has been submitted to the United States Department of Justice for review and administrative approval. The new redistricting plan, enacted as Act No. 75 of 2011 (H. 3992, R. 111) and signed by the Governor on August 1, 2011, impacts all six of the state’s current districts for the United States House of Representatives, and creates a new seventh district in accordance with the nationwide reapportionment of the Congressional House seats.

Because federal law requires that new Congressional Districts must be reviewed by the Department of Justice and administratively approved prior to their being implemented or enforced, this submission, which details the process by which the redistricting plan was enacted, has been made to the Department of Justice in compliance with the Voting Rights Act of 1965, as amended, and the Code of Federal Regulations, Title 28, Part 51. In addition, judicial approval for the redistricting plan is being sought simultaneously through the filing of a complaint in the United States District Court for the District of Columbia seeking a declaration that the redistricting plan conforms to the requirements of Section 5 of the Voting Rights Act of 1965, as amended.
