We know that Federal law requires the state to hold hearings for public input on redistricting.

However, I want to remind you as our legislators, that South Carolina is one of the nine states still under Section 5 of the 1965 Voters Rights Act because of a history of discriminatory acts against minority voters.

I point this out because the overwhelming passage by SC House last week of the Voter ID bill is a sign to me that discrimination against minorities is still alive and well in 2011.

Passing a law that will create voting problems for the elderly and the poor is a sign that discrimination against the disenfranchised is still taking place. This makes us less trusting that you will be fair in redistricting.

I request that House Districts 23 and 25 in Greenville County include "Minority Communities of Interests" with lines drawn to ensure majority-minority representation.

I also request that this body provides fairness and transparency to all citizens by making sure that all public hearing summaries, maps, and submitted redistricting plans are placed on the states' redistricting website in a timely manner. Thank you.

I realize that the lines for each district will be drawn by using the population number of 37,000 people and that this may require some shifting in the present districts. With the growth in our boardering counties, they should give up some, if not all, of their areas in Cherokee County to represent the county in which they reside or areas closest to their home residence. At this time, Representative Dennis Moss has constituents in Cherokee, York and Chester counties. Our county is composed of one city, Gaffney, one town Blacksburg and many small communities. The present lines actually split the City of Gaffney into two sections that have different representatives. Rep. Dennis Moss (House District 29) has the middle of the City of Gaffney to the southeastern part of the county while Rep. Steve Moss (Dist.30) has the middle to the northwestern part of the county including all of the Town of Blacksburg. Three communities Ashbury, Goucher, and Macedonia are represented by Rep. Eddie Talon (Dist. 33) in Spartanburg County. These small communities have far more in common with the City of Gaffney. We share the same educational system, government officials, fire and law enforcement protection and share in our local tax base. Representative Moss's time is not used in an efficient manner due to the area he covers. I would like to have him represent -the Gaffney area and divide the county population with the majority staying in House District 29 (Rep D. Moss). The northern part of our county borders the State of North Carolina and as it moves east/southeast it boarders York County. It would - be a more logical solution to allow the City of Gaffney to be in one house district.

Rep. Dennis Moss has seniority amongst our House members. He is known as the "go to guy" in the areas he represents and also in the ones he does not. It is not uncommon to hear, "Call Dennis" in any area of Cherokee County. He knows our needs and has kept them active and alive in Columbia. Gaffney is our county seat and I strongly disagree with it being split down the middle. By changing the lines to be inclusive of the City of Gaffney and surrounding communities, I feel that he will be better able to focus on specific concerns and better represent the people of Cherokee County. I am a retired Broadcaster having owned a Radio Station but more importantly I was the General Manager of Gaffney's oldest Radio Station. My parents resided in Cherokee County until their deaths. Other extended family members continue to reside within the county. Our children attended and graduated (as did I) from Gaffney High School. One son resides in Gaffney where he is a practicing attorney. My wife is a retired school administrator, is serving as Chairperson for the Cherokee County Disabilities and Special Needs Board, past president of the Cherokee County Association for Retarded Citizens and has served on the First Steps Board for Cherokee County. My name is Jimmy Lamb and I reside at 599 Goucher School Rd, Gaffney which is in the Goucher community of Cherokee County. I serve as the Fire Chief of the Goucher-White Plains Fire Department and am very active locally in many community service groups.

It is my understanding that the South Carolina Legislature is currently re-districting our state. It has long been a concern of mine that my community is in house district 33. Having worked in Spartanburg County while residing in Cherokee County; I've seen the vast differences in the makeup of both counties. Cherokee County is a smaller county with our own unique issues that are very different than Spartanburg County. Cherokee County people are "hometown people" whose lives are closely intertwined with Cherokee County. If there is an issue that arises in my community, our citizens go to local officials to get answers. As the Fire Chief, I deal with local officials including Cherokee County Council, Cherokee County Sheriff's Office, Cherokee County Fire Departments and other Cherokee County organizations. However, as the lines are currently drawn, if I have an issue that needs to be addressed at the state level, I have to go outside of my county for my local representative. This puts us at an unfair disadvantage when seeking representation. Our representative may be pressed by the larger population of Spartanburg County to make decisions and be in favor of issues that my benefit Spartanburg County, but not be in the best interest of Cherokee County. This is in no way a reflection on our current Representative Eddie Talon as I have the utmost admiration and respect for him. It is simply difficult for a person in that position to vote in favor of an issue supporting Cherokee County when more of their constituents are from the Spartanburg area.

I would like to recommend that the Goucher community as well as any other communities in Cherokee County under House District 33 be redrawn to be included in House District 29, currently represented by Dennis Moss. I am aware of the complications of drawing lines and the whole process of redistricting. I do not envy your task and that of the committee.

What I would like to see is as many representatives as possible serving the people of the county in which they live. First, I believe it better serves the citizens of the county and second, I feel that anyone who represents a county in which he or she resides is a better public servant.


