Welcome to the South Carolina Senate's redistricting website. We hope you find it helpful and that it gives you the information you need to become a participant in the redistricting process.

Every ten years, the federal government takes a census. This is required by the United States Constitution and has been done since 1790. Those of you who have used census records in genealogy research know how valuable the information is from an historical standpoint.

The census is also important for drawing fair and effective election districts.

In South Carolina, the General Assembly is responsible for drawing three types of election districts:

- (1) for 46 State Senate seats;
- (2) for 124 State House of Representatives seats; and
- (3) for South Carolina's delegation to the United States House of Representatives.

This is accomplished by passing legislation that contains the redistricting plans for each type of election district.

We must redistrict every ten years to comply with the constitutional requirement of equal representation. The Fourteenth Amendment guarantees that each person's vote must have the same weight as another's. You may have heard this called "one person, one vote."

In order to comply with this requirement, each South Carolina Senate district must contain a substantially equal population. Similarly, each South Carolina House seat must contain a substantially equal population. The federal Constitution also requires that, to the extent practicable, each of our Congressional districts must contain equal population.

As the census numbers reveal changes in how many people live in our state and where they live, district boundaries must be adjusted in order to comply with the requirement of equal representation.

South Carolina's redistricting plans also must comply with the requirements of Sections 2 and 5 of the Voting Rights Act, as well as federal case law prohibiting racial gerrymandering. Links to more information about redistricting law can be found on our website.

In addition, we're waiting to hear if our state's population has grown enough so that we gain another seat in the United States House of Representatives. South Carolina's excellent response rate of 73% -- an eight point improvement over the 2000 census -- makes the gain of a new seat in Congress a real possibility.

The redistricting process will begin when the results of the census are released next spring, no later than April 1, 2011.

In the State Senate, the Judiciary Committee's Redistricting Subcommittee will do much of the necessary work to develop proposals for new districts.

How can you participate in this process?

You've taken the <u>first</u> step by viewing this website. Keep informed through this website and other media sources about the Senate Judiciary Committee's Redistricting Subcommittee. Learn about the subcommittee's schedule, when it will be holding public hearings, and how it will be receiving information and testimony. If you are unable to attend a hearing, visit our website to see other ways to submit your comments.

<u>Second</u>, think about what you would like to tell the subcommittee about your community and its representation.

<u>Third</u>, be an effective communicator. Make the necessary contacts to let the subcommittee staff know that you would like to be heard or have the information you provide considered by the subcommittee. Find out how the subcommittee needs to receive the information. Make your points clearly and concisely. Be prepared to answer questions.

Finally, encourage others to be involved in this process.

I hope you will find this website a good resource. On it, we will announce hearings, as well as provide access to census data, proposed plans, and other information. You may also sign up on the site to receive e-mailed notices of meetings and other announcements. Thank you for your interest. We look forward to hearing from you during the redistricting process.



SENATE AND CONGRESSIONAL REDISTRICTING SINCE 2000

2000: Decennial Census conducted.

2001: The results of the Census were received on March 15, 2001. On August 27, 2001, the General Assembly passed H. 3003, which was vetoed by Governor Hodges. On September 4, 2001, the House failed to override the Governor's veto. A lawsuit was brought in the United States District Court for the District of South Carolina alleging that the General Assembly was unable to pass a redistricting plan and requesting that the court draw a new plan as a remedy for the legislative impasse. A three-judge court convened pursuant to 28 U.S.C. § 2284(a), held a trial, and ordered a redistricting plan into effect for the House, Senate, and Congress on March 20, 2002. <u>Colleton County v. McConnell</u>, 201 F. Supp.2d 618 (2002).

2002: Congressional elections held under plan ordered by the three-judge District Court panel in <u>Colleton County v. McConnell</u>; Special Senate election for Senate District 29, held November 5, 2002, pursuant to court-ordered plan in <u>Colleton County v. McConnell</u> (special election held because of death of state Senator Edward Saleeby on July 6, 2002).

2003: Special Senate election for Senate District 18, held April 15, 2003, under court-ordered plan <u>Colleton County v. McConnell</u>, (special election held because state Senator Andre Bauer was elected Lt. Governor in November 2002 elections); Act 55, S. 591 of 2003 enacted by General Assembly, precleared by the U.S. Dept. of Justice; effective date June 2, 2003.

2004: Special Senate election for Senate District 27, held February 3, 2004, pursuant to Act 55 of 2003, (special election held due to death of state Senator Donald Holland on October 5, 2003); Senate general elections held pursuant to Act 55 of 2003; Congressional elections held pursuant to court-ordered plan in <u>Colleton County v. McConnell</u>.

2006: Congressional elections held pursuant to court-ordered plan in <u>Colleton County v. McConnell</u>; Special Senate election for Senate District 5, held November 7, 2006, pursuant to Act 55 of 2003, (special election held due to resignation of state Senator J. Verne Smith).

2007: Special Senate election for Senate District 46, held June 19, 2007, pursuant to Act 55 of 2003, (special election held because state Senator Scott Richardson appointed as Director, S.C. Dept. of Insurance.); Special Senate election for Senate District 44, held August 7, 2007, pursuant to Act 55 of 2003, (special election held because state Senator William "Bill" Mescher died on April 8, 2007); Special Senate election for Senate District 25, held November 6, 2007, pursuant to Act 55 of 2003, (special election held because state Senator Thomas "Tommy" Moore resigned).

2008: Senate elections held pursuant to Act 55 of 2003; Congressional elections held pursuant to court-ordered plan in Colleton County v. McConnell.

2010: Congressional elections held pursuant to court-ordered plan in Colleton County v. McConnell; 2010 Census is held.

2011: Special Senate election for Senate District 16, scheduled for April 12, 2011, held pursuant to Act 55 of 2003, (special election held due to state Senator "Mick" Mulvaney's election to U.S. Congressional seat).

2012: Senate elections scheduled to be held; Congressional elections scheduled to be held.

- 1. What is redistricting?

Answer: Redistricting means redrawing the boundaries of districts from which public officials are elected. Members of the United States House of Representatives, the South Carolina Senate, and the South Carolina House of Representatives are elected by voters who live in those districts.

2. When is redistricting done?

Answer: Federal law requires that a census of the population of the United States be taken every ten years. The final census data becomes available to the state the year after the census is completed. The census data for South Carolina will be available before April 1, 2011.

3. What is the difference between redistricting and congressional reapportionment?

Answer: Reapportionment occurs every ten years when the 435 seats in the U.S. House of Representatives are reapportioned among the 50 states in accordance with the latest federal census data. Reapportionment occurs when all of the census data is in and states are assigned seats in Congress according to their populations. As a result of the 2010 census, South Carolina has been assigned a new seventh congressional seat. Redistricting is the process of changing the district boundaries. The number of members per district does not change, but the districts' boundaries do. The State Constitution sets the number of State Senators at 46, the same number of counties in the state, so every 10 years the State Senate undergoes redistricting, not reapportionment.

4. Why does the South Carolina Senate have to be redistricted?

Answer: The United States census reveals how the state's population has changed over the past decade. As a result of these changes in population, invariably some districts will have more population than others. Because the United States Constitution's Equal Protection Clause requires each Senate district to be approximately equal in population, the Senate district boundaries have to change every 10 years, in order to equalize their population.

5. What process or procedures does the S.C. Senate use to redistrict?

Answer: The Chairman of the S.C. Senate Judiciary Committee, Senator Glenn F. McConnell, will appoint a redistricting subcommittee which will be charged with drawing a plan for the Senate's consideration. Public hearings will be held around the state shortly after the census data is released to South Carolina, so that the public can tell the Redistricting Subcommittee about factors it should consider in the course of its work.

After hearing from the public, the Redistricting Subcommittee will develop a list of criteria to use as a guide to developing a plan. The Redistricting Subcommittee will also hold public meetings in order to allow the public to comment on proposed redistricting plans. Interested groups will be able to submit plans for the subcommittee to consider. The Redistricting Subcommittee will propose a plan to the Senate Judiciary Committee in the form of a proposed bill. If the Senate Judiciary Committee approves the proposed plan, then the bill goes to the full Senate for two further readings. If it receives a majority vote, the bill will be sent to the House of Representatives. If the House passes the bill, it will be submitted to the Governor for signature or veto. If the Governor does not veto the bill, the Senate Redistricting bill will be enacted into law. In the event of a veto, the House and Senate would each have to override the Governor's veto by a two-thirds vote in order for the bill to become law. Once enacted, the new redistricting law will have to be pre-cleared by the U.S. Department of Justice or the United States District Court for the District of Columbia before it can take effect.



Introduction

Every 10 years, following the U.S. census, all local, state and federal election districts must be remapped to account for a growing and mobile population. State legislatures are largely responsible for conducting the constitutionally mandated redistricting of U.S. House and state legislative districts. During the past four decades, federal and state laws governing the redistricting process have expanded dramatically.

This fourth edition of NCSL's Redistricting Law summarizes the extensive legal framework that governs the process of redistricting. It is intended


